Elite Athlete Program (EAP) form currently says "represent country". Review as a committee around whether we change the criteria to "Australia" moving forward, or if it includes any country of origin.

AL- Agree to update to "Represent Australia" but I am sure we agreed to support Benji (\$1000 from memory) this time around given his offer to train groms.

JP - I'm trying to think fwd to future scenarios (Pelmores and Reynolds) and think if we update the policy to Representing Australia it makes things cleaner if we want to exclude those representing other countries. I think though if we decide to pay Benji based on his offer to train then we muddy the waters for future scenarios. I suggest we withdraw the offer to Benji and he can offer a fee for service training to the groms separately. This way it's cleaner for future scenarios.. Worth a conversation then a vote, options as I see them.





- 1. Leave as representing the country but require all those who receive support (irrespective of country) to give back to the club commensurately with the size of the support they receive.
- 2. Change to Representing Australia and withdraw Benji offer to clean up precedent for future scenarios.
